

HINA MAUKA WHAT TO BRING

- 1 Picture Identification (license, State ID, etc.) and/or proof of citizenship
 - 2 Current medical card (if any) and EBT card. **Your EBT card needs to be turned in to Hina Mauka while you are a resident. This will be used to pay for your daily meals (\$6/day) If not, you must bring \$180.00 to pay for meals. Not adhering to this may cause delays in your admission. We are required by law to report to DHS of your residence at Hina Mauka.**
 - 3 Current copy of physical and TB results, within the past 12 months (or have faxed, 808-236-2626)
 - 4 Current bank statement. Needed to apply for DHS benefits (if needed).
 - 5 Dual-Diagnosed clients: A current psychiatric evaluation and medication list is required upon admission.

Personal care items: Toothbrush, toothpaste, shaving gear, bath soap and shampoo. Footwear is required at all times. Shoes that can be used outdoors a must. Bring enough clothing for at least a week. Writing materials: 1 Spiral Notebook, pens, pencils, etc. You are responsible for your own personal items. **Hina Mauka is not responsible for any lost, stolen or damaged items.**
OPTIONAL: alarm clock, stamps & envelopes, phone card, favorite pillow, blanket and/or sheets.

REGARDING MEDICATION

All medication must be turned over to staff upon admission. **Please bring a 30-day supply of medications, if any.** Hina Mauka will monitor your medications according to the physician's labeled directions. In order to maintain a safe, clean and sober environment, any medication reviewed by our doctor deemed "inappropriate" will be discarded. All controlled medications to include: Benzodiazepines or Narcotics (Valium, Klonopin, Ativan, Codeine, Percocet, Oxycodone, etc.), will be reviewed by our doctor prior to your admission. If you are taking these medications, please notify Hina Mauka admissions as soon as possible to expedite the admission and review process by our doctor.

WHAT NOT TO BRING

Illegal drugs, alcohol, e-cigarettes, and inappropriate objects/weapons are forbidden.

Clothing/Jewelry that promotes alcohol, drugs, gangs or violence. No tank top or clothing that shows skin/midriff. Expensive jewelry or other expensive items. Cameras, walkmans, TV's, anything not related to treatment. Books that are not recovery in nature. Mouthwash, etc. that contain alcohol. All you require are the items we recommend you bring. Any items deemed inappropriate by staff need to be picked up by a friend/family member. Until such arrangements are made Hina Mauka will store the items, however, **Hina Mauka is not responsible for any lost, stolen or damaged items.**

Items may be dropped off. You may choose to have a friend or family member/supportive person drop off items for you. However, counselor/staff person must clear them before you receive them.

It is highly recommended that you have no contact for the first 72 hours. This time is to help you become acclimated to the treatment environment. After 72 hours you may make calls and receive messages. Hina Mauka staff request that you keep us informed of requested court appearances so that staff can make appropriate accommodations. **42 CFR Confidentiality laws prohibit us from releasing any information on your behalf without appropriate signed consents by you.**

Visitations is on Sunday only once your requested family members have been cleared by our family counselor. Please ask our intake staff for more information upon admission. Family and friends may come in and have lunch with you at 12 noon. The cost is \$5.00 for adults and \$2.00 for children. An AA meeting, following lunch, is from 1:00 to 2:15. Regular visiting is between 2:30 and 4:30. Children must be supervised at all times by an adult other than client.
